**Call to Order:**

- Co-chairman Tasa called the meeting to order at 4:00 pm.

**Approval of Minutes:**

- ***DUI Drill*** – The DL reported that she has been trying to get ahold of Mark dos Remedios to discuss the billing method and other items. She will try to catch up to him soon.
- ***EMS Levy Meeting*** – Tasa reported that this was actually a meeting put on by VFIS. Gordon MacIlvennie (from VFIS) would like to combine some area department and form an insurance pool. All departments would share in the costs and any claims. Tasa recommended that the District not join. Our premiums might be higher and the liability greater. Gordon is putting together a proposal; the Board will make a decision after receiving the proposal.
- ***SOA Report*** – The DL informed the Board that the report for 2012 is complete. She received a lot of help from the auditor.

- ***Audit*** – The audit for the years 2010 through 2012 has been completed. She will relay the findings after the post-interview.

The crews go out into the community and try to reach as many people as they can by taking blood pressures & blood sugar readings. So far they have done 45,000 screenings, with 7,000 referrals to consult their doctor. He asked that if the Commissioners know of any groups in the District's area that might like this service, to contact Station Captain Kullberg at Sta #16.
