- ***City Council Retreat*** – Chief Peterson attended the Council Retreat. One of their discussion points was Fiscal Sustainability. The City’s expenditures are higher than their revenue. The Fire Department has four options available to them:
  - Develop an RFA
  - Institute a Business & Occupation Tax
  - Institute a Maintenance & Operations Tax
  - Benefit Service Charge

At this time, it is appearing that an RFA is the department’s best option. It would probably remain small at this point and just include Renton, District #25 and District #40. Tukwila and District #20 are also possibilities. Renton Finance will be working on the numbers.
