- Hiring: We will be conducting final interviews of the top 11 candidates for firefighter on July 10 and July 12 and will make conditional job offers on July 12. We anticipate on-boarding our six new firefighters beginning August 16.
- Fire Station 15: We will be attending an Open House on July 12 from 6-8 pm in the North Highlands Community Center Gymnasium. This will be the first chance for the public to view the conceptual drawings of Fire Station 15. Governing Board members are encouraged to participate.
- Sobering Center: Statistics on the Sobering Center were presented to the Board as follows:
 - 195 admissions to the Sobering Center (SC) to-date; 116 of which were self-referrals.
 - 56 unique patients have been referred to the Sobering Center.
 - This coming month, we will focus on increasing referrals to the SC.
