CALL TO ORDER AND FLAG SALUTE

STATION 15 CONSTRUCTION COSTS

Since December of 2016, RRFA Staff have worked in conjunction with the City of Renton and architects to design a fire station within a specific set of parameters – specifically, a single story fire station, with no more than three bays, and no larger than 7500 square feet. These were the parameters set as a result of the original allocated funds of \$5.5 million.

A meeting was held in July with the City, and the RRFA was told that the proposed fire station was estimated to be over budget by \$1.2 million and the options were either to decrease the station size or have the RFA provide additional funds to complete the station as proposed.

Chief Marshall recommended to the Board that the RRFA take the following actions to provide the funding necessary to complete the construction of the station:

- 1. Ensure that the fire station stays within the 7500 square foot parameter.
- 2. Agree to shift the \$1 million set aside in the Equipment Rental Fund to the Construction
- 3. Purchase necessary furnishings through the 2018 Operations Budget.
- 4. Reevaluate the current Capital Equipment (Fleet) replacement schedule to address equipment needs and replacement cycles.
- 5. Postpone if necessary new positions budgeted in 2018 currently FD Cares, Fire Inspector and IT.

A **MOTION** was made by Board Member Persson and **SECONDED** by Board Chair Prince to authorize the Chief to inform the City that we will cover up to an additional \$1 million with the caveat that an agreement (ILA) be put in place.

Discussion on the motion: Chief Marshall summarized what was talked about including the Board wanting an agreement with the City and also to see what the estimates are. Board Vice Chair Barilleaux suggested asking the City if they would split the difference of the overage and it was decided that the City wouldn't agree to that. Board Member Persson suggested a Governance Board sub-committee of two people to work with the RFA Administration more in-depth on the 2018 budget. Board Member Pavone asked for a breakdown of what the station costs are.
