CHIEF'S REPORT

Chief Marshall's report included the following:

- New Member: Ken Kiker, Deputy Fire Marshal, began his employment with RRFA on June 1, 2017.
- Hiring: Six new recruits begin on Wednesday, August 16th. Job postings for Finance
 Analyst and Communications Manager will be available on Monday, August 14. The
 positions will be open until filled with the first review after two weeks. Additionally, the
 hiring process will start for six more entry-level firefighters.
- KCFD20: Fire Chief Eric Hicks sends his thanks for the assistance we provided on July 11 at the third alarm structure fire on Beacon Coal Mine Rd.
- House Fire: On August 5, Renton Fire crews were dispatched to a fire at a residence in the Maplewood Heights neighborhood. Thanks to the quick actions of the crews, we were able to minimize damage to the adjacent houses. All occupants were able to escape without injury. There was no immediate reports of firefighter injury. The cause of the fire is listed as accidental due to the improper disposal of cigarette butts. The estimated damage loss is \$376,000 (the value of the home listed on the King County Assessor's web site) and an estimated \$45,000 of content loss.
- Logistics Co-Op: Participation in the regional effort to combine Logistics service is
 moving forward. To date, we have developed the financial and legal framework,
 selected members of the advisory committee to represent each participating
 organization that will approve the tools / equipment / supplies a combined Logistics
 would provide, selected a consultant group to design a regional Logistics supply chain
 model, and we're finishing up a detailed comparison of what each organization
 currently purchases individually for cost comparison. If successful with this regional
 venture, we will be partnering with neighboring organizations to gain needed
 efficiencies while improving the effectiveness of the core service of Logistics. Gaining
 efficiency and effectiveness in services demonstrate accountability to our customers,
 and is essential as an RFA.
- Members of the Quarter: Nominations were held for our quarterly recognitions. The following members were chosen for this great honor: Officer – Captain Will Aho, Firefighter – Todd Fisher, Civilian – Jennifer Zinck.
