- Commissioner Abercrombie asked if there was any data from the RFA vote, in particular if it was possible to break out the percentage of people in the district and Kennydale that voted for the RFA. Chief Peterson responded that the only data available was raw. They would need a GIS person to plot the data. Local 864 may have a consultant that could help.
- Commissioner Abercrombie inquired about specific response time data. Chief Peterson
 informed him that in order to get the information, their data person has to use a
 cumbersome process with pivot tables. They would need a GIS person to plot the data.
 There is some data available in COR maps (available on the City website rentonwa.gov).
 He also felt that data reporting is not standardized across the valley so it is difficult to get
 comparables.

Items listed on the Consent Agenda were the meeting minutes from April 19, 2016 and the expense fund vouchers. Commissioner Barilleaux made a **MOTION** to approve the Consent Calendar in its entirety. **SECONDED** and **CARRIED (3-0)**.

- Interlocal Agreement (ILA): Commissioner Abercrombie attended a meeting with Councilman Prince, Chief Peterson, BC Marshall and the City Attorney to discuss the ILA.
 - He was concerned that if the District acquired any equipment, they would need a new contract. Commissioner Meikle informed him that the District had no assets; they have already turned everything over to the City.
 - Commissioner Abercrombie requested that some type of verbage be put in the ILA to address the DUI/Texting (Distracted Driving) Drill. He would like to see the program expanded to maybe twice a year.
 - Chief Peterson explained that the ILA outlines what the City will provide for the RFA and what the RFA will provide to the City.
