**Call to Order:**

- Chairman Barilleaux called the meeting to order at 4:00 pm.

**Approval of Minutes:**

- **MOTION** made by Tasa to approve the minutes of the regular meeting of March 18, 2014. **SECONDED** and **CARRIED**.

**Unfinished/Old Business:**

- ***CPR Class Update*** – The DL reported the April class was full with a waiting list.
- ***Trusteed Update*** – The DL reported that she contacted Sylvia from Trusteed and she explained that the reason for not receiving a bill for March and April was that Steve Krohn had turned 65 and Trusteed is now his secondary insurance. We will not receive a bill for May; the amount due in June is \$1815.77. All 3 retirees have now reached 65.
- ***Commissioner Replacement*** – Tasa contacted the City regarding the Alpine Nursery annexation and it will become final in late June or early July. He suggested that he wait until to June to resign. He gave a brief overview of the budget and contract with the City for Bergquist.

**New Business:**

- ***Fiscal Sustainability*** – Chief Peterson, Jay Covington, and Iwen Wang made a presentation to the Council on the Fire Department’s options:
  - Develop an RFA
  - Institute a Business & Occupation Tax
  - Institute a Maintenance & Operations Tax
  - Benefit Service Charge

At this time, it is appearing that an RFA is the department’s best option. They received no direction from the City Council, however, the Mayor has sent a letter to the districts soliciting their interest in developing an RFA.
