#### **BOARD COMMITTEE REPORTS**

#### **CHIEF'S REPORT**

Chief Marshall's report included the following:

- Renton RFA Career Con: On Monday, August 13 and Saturday, August 18, we held our first ever Renton Career-Con at Station 14. There was an exceptional turn out with around 90 attendees. Chief Marshall would like to recognize Director Babich, DC Gunsolus, and DC DeSmith for their team's efforts to make this so successful.
- Budget Time: Budget season is in full swing for all of the Budget Line Item Account Managers. Our first budget workshop will be on Wednesday, August 29, in the Station 13 Conference Room.
- Station 15 Update: Robert Ebert has left the City of Renton and is no longer managing the Fire Station 15 project. There is currently a search underway for his replacement. Until one is found, Facilities Director Jeff Minisci is managing the project. Prior to leaving, Robert sent over several files regarding Fire Station 15. We are currently within budget and have a significant portion of contingency funds still available.
- Congressman Adam Smith Visit: Chief Marshall was invited to be a part of a panel of local
  public safety chiefs to discuss existing and emerging issues related to public safety with
  Congressman Adam Smith. Among the topics discussed were homelessness, opioids, and
  low-acuity response impacts.
- KIRO 7 News Story FirstNet: Recently, a new story developed out of the California
  wildfires that involved the throttling of emergency services data by Verizon. That
  prompted KIRO 7 to reach out to the RFA who had recently made the switch to AT&T
  FirstNet. FirstNet is designed to have dedicated and un-throttled voice and high speed
  data available to emergency services. This situation highlights the importance of
  communications and illustrates why we made the switch to FirstNet.
- Valley Medical and Renton School Dist. Board Meetings: Chief Marshall attended Board
  meetings for both UW Valley Medical Center and Renton School District to thank them for
  their partnership in our Healthy Heart Initiative and present certificates of appreciation to
  their members who were instrumental in the program this year.
- Fairwood House Fire: One person was displaced following a 2-alarm fire in the Fairwood area of Renton on Friday, August 10. Firefighters were able to control both the house and tree fires, protecting the apartments from damage.

 Fatality Car/Pedestrian Accident: Shortly after midnight on Saturday, August 18, RRFA and Renton Police responded to a car versus pedestrian on NE Sunset Blvd just north of NE 12
 ST. Aid 12 and Engine 12 immediately began CPR on an approximately 60 year old male pedestrian who passed away at the scene. Renton PD is investigating.

#### **DIVISION REPORTS**

Director of Administration, Samantha Babich, gave an overview of the Career-Con event that took place on both August 13 and August 18. There were approximately 40-50 people attend the event on each day. The RFA team rallied to bring the event together in less than two weeks with minimal cost associated. The event was very successful.

#### Dawson Bain



Deputy Chief DeSmith will have an agenda item today for Bunker Gear replacement in the amount of \$65,000. This cost is currently in the budget.

#### 4. Citizen Advisory Panel

On Sept. 6, I convened a Citizen Advisory Panel to help our organization obtain direct input from citizens in the community we protect. We reviewed the 2017 annual report, Standards of Cover, and Mission Statement. In addition, they drafted bylaws that are coming before the Board for adoption.

#### 5. Salvation Army Advisory Panel

I was asked to join the Salvation Army Advisory Panel to which I gladly accepted. The Salvation Army provides resources to those less fortunate and in need through our community and this is one way that our fire department can give back.

#### 6. Washington Survey and Rating Bureau (WSRB)

The WSRB met with staff on September 6 for our new rating that will take effect next year. This rating is given every 5 years and is a significant factor in insurance rates for our community. I would like to recognize the work of the Executive Team in this endeavor. Several factors turned, what was 4 years ago, a laborious 2-day process, to only 3 hours last week. The factors included are the record keeping of training hours provided by the South King County Training Consortium and having so many processes on SharePoint. I am confident that we will maintain our rating of 3 for the next 5 years, and will report to the Board as soon as it is confirmed.

#### 7. Station 15 Update

Framing is now complete and mechanical, electrical, plumbing, HVAC, and sprinkler installation is underway.
