• 2021 Firefighter Holiday Adopt-A-Family Program

Our members, in partnership with the Renton Firefighters Benevolent Association, Local 864 Firefighters Union and Communities in Schools of Renton, Renton RFA adopted eight families this year in the annual holiday adopt-a-family program. The Union Pumper is scheduled to visit families and deliver gifts (with Santa!) on Wednesday, December 22nd. • Diversity & Inclusion Workshop

I'm participating in a diversity and inclusion workshop on Saturday, December 11th hosted by the King County Fire Chiefs Association. We coordinated with the City of Renton's Equity, Housing, and Human Services department to send invitations out to our diverse community to provide information for the event and offer the opportunity to participate, which resulted in all120 slots filled. The focus of the workshop is on the hiring process, mentoring and preparation for a career in the fire service.

Everson Flood Deployment

Since the flooding began, everyone from law enforcement and first responders to mayors, neighbors and local agencies have been answering the call to help. On November 27th and 28th, Battalion Chief Steve Winter and Firefighters Adam Bloom and Angus Brackett were deployed in response to the latest round of river flooding in the Everson area of Whatcom County. These members are part of our dive team, and I want to personally thank each of them for their assistance to our neighbors during this time.

DIVISION REPORTS

EMS/Health Safety

 Deputy Chief DeSmith updated the board on a FEMA Female Firefighter Cancer Cohort Study involving two recruit female FFs and two tenured female FFs. The study focuses on job stress and exposures experienced by female FFs. GEMT is in its final approval stage for April 2022 start date. The CARES unit hired two new RNs and ride alongs on CARES 314 are available to District 40 commissioners.

Office of the Fire Marshal

• Fire Marshal Barton provided a quarterly report which included a year-to-date inspection number of 4,560. Dollar losses are up this year due to the nature of incendiary fires. Construction is increasing and as a result plan review is up. New projects include Sunset Garden Apts, Watershed Apts, and Cedar River Apts. King County Fire Marshal has informed that there are no deputy fire marshals and have put a hold on permitting. Public outreach efforts continue with school visits, social media messaging, and smoke alarm installs.

 Deputy Chief Seaver updated the Board - Station 11 remodel is underway with demo work and the contractor has 90 days for project completion. Ladder 311 at night is docking at ST12.
 The new aid car purchase will be arriving soon. Station 15 has been completely mitigated for the flooding incident and all bills have been submitted to the City of Renton for a total of \$44,093. Surplus vehicles thus far have totaled \$34,488 and logistics was able to acquire additional PPE masks/gloves.





King County Fire District No. 20 - Skyway Fire Patient Number: 6962

Patient is a 96-year-old female who was referred by Skyway on 8/30/2021 due to increase 911 calls and convinced she was being poisoned by caretakers. Patient had moved up to Washington State recently to live with her family in a home. Agitation, mood, and behavioral issues with family members were escalating. She is mostly independent taking care of herself but needing assistance with some activities of daily living. Was screened by Valley Medical Center Social Services Worker for COPES and possible assistance for VA benefits since she was married to a Veteran. Has issues with her ability to write so Social Services to assist with filling out paperwork. Diagnosed with dementia by her primary physician. APS report was done. Medical and financial DPOA was contacted to assisted with paperwork from out of state. Valley Medical SSW gave referral to Marie Casanova, SSW, City of Seattle, Aging and Disability Hospital Discharge Navigator. A combined effort resulted in patient moving from living with family members in a private residence to an Adult Family Home. Currently is living at an Adult Family Home. Last 911 call on 10/10/2021.



Staff completed 4,932 inspections (business, multi-family, IFC permit, special, complaint & re-inspections) in 2021.


Inspections Completed by Quarter - Comparative to 2020




Fire Investigations

Fire Investigations by Quarter - Comparative to 2020




Fires by Type & Dollar Loss

Plans Review, Construction Inspections & Permits by Quarter - Comparative to 2020




Public Education / Community Outreach Highlights
