## **NEW BUSINESS**

- The Probationary Member termination was presented for consent. Moved by Jim Matthew and Seconded by Sanjeev Yonzon to consent to the discharge of one probation member per 16.09 Civil Service Rules. Carried.
- Proposed Rule Change to 8.14 Civil Service Rules, Promotional Examination/Frequency Of/Advance Notice presented to commission. This change allows the RFA to require members who have 5 years of paid professional firefighting experience, with three (3) of those years employed with RRFA to be eligible to take a promotional exam.
- Proposed Rule Change to 12.02 Civil Service Rules, Length of Probationary Period presented to commission. This change allows the appointing authority to terminate the employment of the person certified or return that person to the rank held immediately prior to the reduction if the appointing authority deems the employee unfit or unsatisfactory for service in the position.
- Proposed Rule Change to 17.04 Civil Service Rules, Reduction in Lieu of Layoff presented to commission. This change allows that at the time of any layoff, certified employees shall be given an opportunity to accept reduction to the rank held immediately prior to the reduction, provided, that any employee so reduced shall be entitled to credit for any previous regular service in the lower class and to any other service credit.
