This letter authorizes KC EMS to utilize the 2023 KC EMS QA/QI BLS allocations from all Zone 3 Fire Agencies that are members of the South King County Fire Training Consortium. This allotment will be used for ALS staffing and assist in funding the King County Medic One MSO6 position.

All other KC EMS BLS allocations will not be impacted by this authorization. The SKCFTC Training Administration Board approved the use of the QA/QI reallocation at the November 2, 2022, board meeting. The following was recorded in the meeting minutes:

- *Chief Heitman requested board approval for KCM1 contract with caveat that BLS funding can be used for ALS. Chief Fehr motioned for QA/QI funds to be used in ILA contract, Chief Hicks seconded motion. **APPROVED.***
