#### **APPROVAL OF MINUTES**

### **PUBLIC COMMENT**

Public Comment was given by Robbie Hyslop and Craig Soucy regarding external hiring process.

### **UNFINISHED BUSINESS**

• Proposed Rule Change to Rule 11.03 (withholding/removing names from eligibility list) presented to commission during the last meeting. This adds language to allow flexibility to remove candidates from the eligibility list for other material reasons, subject to approval by the commission. Motion to approve rule change made by Ray Barilleaux. Seconded by Sanjeev Yonzon. Carried.

### **NEW BUSINESS**

- Proposed Civil Service Rule Change Rule 12.02 Length of Probationary Period (new hire firefighters). This adds language to extend new hire firefighter probationary period to start at date of hire and conclude 9 months after the first shift worked in response operations.
- Proposed Civil Service Rule Change Rule 10.05 Duration of Eligibility Lists (Promotional List). This adds language to remove the rank of Deputy Fire Chief from the 2 year eligibility list, instead making the list to be in effect until the end of the current hiring process and may be extended by the commission upon request of the Fire Chief. The ranks of Engineer, Lieutenant, Captain and Battalion Chief remain the same with a 2 year eligibility list.
- Deputy Fire Chief Internal/External Process to Fill Open Vacancy Rule 8.15 Promotional Examinations-Limitations. Discussion held regarding the vacant Deputy Fire Chief position to be held internally and externally to find candidates. Commissioners unanimously agreed that the RFA should hold an internal process first before opening it to external candidates. Motion made by Ray Barilleaux. Seconded by Sanjeev Yonzon. Carried.

- Deputy Fire Marshal Eligibility list presented for certification. Motion made to certify the eligibility list made by Ray Barilleaux. Seconded by Sanjeev Yonzon. Carried.
- Probationary Member termination was presented for consent. Moved by Ray Barilleaux and Seconded by Sanjeev Yonzon to consent to the discharge of one probation member per 16.09 Civil Service Rules. Carried.
- Civil Service Chief Examiner/Secretary Jennifer Zinck advised she is removing herself from the Deputy Fire Chief Promotional Process and that process will be led by Samantha Babich.
