1. Congratulations are in Order

Please join me in congratulating FF Jessica Clearman and Joseph Munden in their completion of JATC. They will officially earn journeyman status upon their 3rd anniversary on December 31st of this year.

2. Salvation Army Red Kettle Day

Volunteers are the difference between an empty kettle and one that raises about \$30 per hour – enough to provide a family with two bags of groceries, or shelter an individual for a night. On Saturday, December 2nd, volunteers from Renton RFA stood together in the front of Fred Meyer on Rainier Avenue to ring the bell and support the Renton community this holiday season, raising \$1,002.46 for Salvation Army.

3. 2023 Adopt-A-Family Program

Renton RFA, in partnership with the IAFF Local 864 Firefighters and Communities in Schools of Renton, will be providing families in need with holiday gifts and meals once again this year. The fire stations and the day staff team each sponsor one family, totaling 8 families for the organization. We plan to deliver gifts to the families with Santa and his driver elf in the Union Pumper on Saturday, December 23rd. If weather poses a challenge that day, the backup plan is to utilize the brush rig.

4. Battle of the Badges Event

On Friday, December 8th, Renton RFA participated in the annual Battle of the Badges event hosted by Renton PD at the Renton Community Center. This event is a food drive and drive-through holiday light display competition between law enforcement and healthcare agencies from the surrounding area at the local and state level. Our theme this year was "The Tale of Grinch Wars," which is a mash-up of Star Wars and the Grinch that included a story line with personnel dressed in costume for the full effect. Staff prepared hot cocoa swag packs and a back drop of the Death Star descending upon Hothville to hang on the engine that was decorated with lights.

5. Communication Updates

I met with Communications Manager Katie Lewis and Union President Andrew Plumlee again to film our second *Ask Me Anything* video to answer questions anonymously submitted my members. We answered 17 questions for the first video and 8 questions this time around.

On November 29th, I participated in the Fire Chiefs Leadership Forum during an annual Battalion Chief training at the South King County Fire Training Consortium (SKCFTC). Fire chiefs were also present from PSRFA, VRFA and Skyway Fire. We started off with prepared questions and then turned to answering questions by those in attendance of the training. The feedback we received was very productive and we are planning to do this each year going forward at this BC training.

6. Theory of Accountability

DC Chuck DeSmith and I attended the *Theory of Accountability* training at the SKCFTC on November 30th with 10 Response Ops members from Renton RFA. Sam Silverstein's insights were thought-provoking, and key takeaways include the importance of individual responsibility and how personal accountability contributes to the overall success of our team; the need for fostering a culture of accountability within the organization; and the idea that accountability is not just a buzzword but a fundamental aspect of achieving our organizational objectives. This training will result in a department culture survey by Mr. Silverstein.

7. King County Fire Chiefs Association Treasurer Update

After six rewarding years serving on the Executive Board, I have decided to step down and transfer the treasurer position to Chief Hicks effective January 1, 2024. It has been an incredible journey, and I'm grateful for the opportunities to contribute to our zone's growth and success. I look forward to supporting the new leadership and exploring new avenues within the team.






Staff have completed 4,004 inspections (business, multi-family, IFC permit, special, complaint & re-inspections) year to date.



Fire Investigations


Staff have investigated 39 fires this year. Total dollar loss for the year is estimated at \$7.2 million.








PROPERTY TYPE OF INVESTIGATED FIRES



Plans Review, Construction Inspections & Permits


Staff completed 773 plans reviews, 489 construction inspections, and issued 200 fire systems and/or fire construction permits year to date.






Public Education / Community Outreach Highlights


- Response ops crews and our public educators visited Honey Dew Elementary schools, along with Rainier Christian reaching 311 students.

- The public educators and response ops crews visited Renton Park Elementary and taught fire safety to special needs students, with 11 students participating.






