SUBJECT:	Promotional Examination to Establish Eligibility List for: BATTALION CHIEF/SAFETY OFFICER
NATURE OF WORK	Oversee a battalion in the Renton Regional Fire Authority. Work involves responding to and dealing with man-made and natural disasters that pose a threat to public safety. Responsibilities include direct and indirect reports and performance management of staff (promote, coach, mentor, and discipline). In addition, budget preparation and control, project management, program planning, goal setting, establishment of performance measures and policy development, updates, interpretation, and administration.
ELIGIBILITY REQUIREMENTS	 Eligibility requirements include all the following: The Fire Battalion Chief/Safety Officer promotional examination is open to Fire Captains of the Renton Regional Fire Authority who have at least one year of experience post probation in the rank of Captain, as of exam date. Employees hired on or after January 1, 1997, are required to have a BA/BS degree, in addition to a two-year degree with fire emphasis to qualify for the promotional exam. Valid driver's license. Must be a citizen of the United States or a lawful permanent resident and able to read and write the English language as specified in RCW 41.08.070. Graduation from a standard high school, vocational school or equivalent. Incident Command System (ICS) 400 within one year of promotion. Safety Officer Certification. HazMat Incident Command Certification. Blue Card Certification or SKCFTC ICS Certification. Completed Acting Battalion Chief Task Book by application deadline.
EXAMINATION PROCESS	The Assessment Center will be held on October 3, 2024. The Assessment Center will be worth 100% of the candidates' final score. The Assessment Center will consist of the following four (4) equally weighted parts: • Tactical Exam (25%) - the Incident Management Simulation. All candidates must successfully pass this element with a score of 70% or greater. • Management Exercise (25%) - a scenario-based exercise based on a personnel, citizen, or other management issue. • Oral Resume (25%) - candidates will provide a presentation outlining their work-related accomplishments. • Oral/Written Presentation (25%) - consists of an oral presentation of your assigned subject and follow-up questions before a panel. The combined overall score for the Management Exercise, Oral Resume, and Oral Presentation will require a minimum score of 70% or greater. Candidates will be ranked on a two-year eligibility list according to their total earned score, plus seniority, education, and certification points.
