
WILLIAM MILLENAAR


Inspections


Staff completed 781 inspections (business, multi-family, IFC permit, special, complaint & re-inspections) in January.



Fire Investigations


Staff investigated 3 fires in January. Total dollar loss for the year is estimated at \$300,000, and an estimated \$4.5 million in saved property.





Plans Review, Construction Inspections & Permits


Staff completed 79 plans reviews, 30 construction inspections, and issued 23 fire systems and/or fire construction permits in January.

The Department participated in 18 educational events, reaching 255 attendees and an additional 7 community events, reaching 656 attendees in January.




Highlights:


False Alarms


