

# **Fairwood Voters Decide Whether to** Permanently Join Renton RFA in April

On April 22, 2025, voters in King County Fire District 40 (KCFD 40) will have the opportunity to vote on Proposition 1, a ballot measure that will determine whether KCFD 40 permanently joins Renton Regional Fire Authority (Renton RFA) for fire and emergency medical services.

For the past 17 years, Renton RFA has provided fire and emergency medical services to KCFD 40 under a contract agreement. Both agencies operate under a two-part funding model, which includes a property tax levy and a fire benefit charge. In 2023, voters in both jurisdictions approved a levy lid lift, setting a rate of \$1.00 per \$1,000 of assessed property value with an adjustment for inflation over the next five years, making these funding systems nearly identical. Proposition 1 asks voters to decide if KCFD 40 should be formally annexed into Renton RFA, which would merge the agencies permanently.

#### **IF PROP 1 IS APPROVED**

If Prop 1 is approved, the \$6.3 million contract between KCFD 40 and Renton RFA for fire and emergency medical services will be eliminated and KCFD 40 will become a permanent part of Renton RFA's iurisdiction, which is funded by the same type of two-part funding model

that KCFD 40 already uses. This merger would make implementing adjustments in service based on the needs of the Fairwood community more agile, as they would not have to be reviewed and approved as an addendum to the current contract.

KCFD 40 would also receive additional representation on the Renton RFA Governance Board. Currently, KCFD 40 is represented by a single, nonvoting member. While their input is invaluable to the Renton community, their ability to affect change is limited based on the nonvoting status of their seat on the Board. If Prop 1 is passed, KCFD 40 will have two voting members on the Renton RFA Governance Board, giving them greater input on the financial decision-making of the organization.

Additionally, the costs for KCFD 40 capital projects, such as the construction of a fire station or the purchase of a new fire engine, would be spread across Renton RFA's entire jurisdiction, rather than being solely funded by KCFD 40 taxpayers. This will reduce the financial impact of KCFD 40 capital projects on Fairwood taxpayers through cost-sharing.

There will also be a reduction in overhead costs and workload for KCFD 40 Fire Commissioners. If Prop 1 is approved, administrative responsibilities will be handled by Renton RFA administrative staff. Contracts for IT and Fire Marshal services currently in place will also be eliminated, as Renton RFA will provide those services to Fairwood as a part of its jurisdiction.

#### **IF PROP 1 IS REJECTED**

If the measure is rejected, KCFD 40 will continue to contract fire and emergency medical services from Renton RFA at an annual cost of \$6.3 million, based on the 2025 contract fee. Funding for future capital projects will remain the responsibility of KCFD 40 taxpayers alone, and governance will continue with KCFD 40 holding one non-voting seat on the Renton RFA Governance Board. The costs of maintaining the KCFD 40 Board of Fire Commissioners, as well as contracts for IT and Fire Marshal services, will also remain in place.

The outcome of Proposition 1 will determine the future structure of fire and emergency medical services in Fairwood. Residents are encouraged to review the details of the measure and participate in the election by casting their vote on April 22, 2025.





#### **Smoke Alarms Save Lives**

Having working smoke alarms is one of the most important ways that you can protect yourself and those living in your home from fire. They provide early detection of smoke and give you time to get outside safely. According to the National Fire Prevention Association, it is estimated that three out of five fire related deaths occur in homes without smoke alarms or with non-working smoke alarms. Smoke alarms save lives and should be present in every home.

#### Where do I install my smoke alarms?

Every home should have smoke alarms and they should be installed

on every level of the home, including the basement, in every bedroom and outside of every sleeping area. They should be placed on the ceiling or high up on the wall. For the best protection, interconnect all smoke alarms in your home. When smoke alarms are interconnected, when one sounds, they all sound. This can be especially important if you close your doors when sleeping.

#### How often should I test my smoke alarms?

All smoke alarms in the home should be tested monthly. You can test your smoke alarm by pressing and holding down the "test" button. If the alarm sounds, the detector is

working. If it does not, it may be time to replace the batteries or get a new smoke alarm. Ensure that everyone in your home knows what the smoke alarm sounds like and how to react if the alarm goes off.

#### When do I need to replace my smoke alarms?

It is recommended that you replace smoke alarms 10 years after the manufacture date or if they don't respond properly when tested. You can find the manufacture date on the back of your smoke alarm if you aren't sure how old it is. If your smoke alarm chirps, this is a sign that the batteries are low and need to be replaced.

#### **Progress Update: Fire Station 16**

The development of the new Fire Station 16 continues to move forward, bringing Renton Regional Fire Authority closer to a facility that will support both the firefighters who serve our community and the growing needs of the surrounding area. Recently, concept drawings for the new station were presented, offering an exciting look at the vision for this state-of-the-art facility. However, it's important to note that these renderings are conceptual and may not entirely reflect the final

design of the completed station.

Fire Station 16 is being designed with the future in mind. One of its key features is the inclusion of hot, warm, and cold zones, which will help prevent contamination from the apparatus bay or emergency calls from reaching the station's living quarters. This will enhance firefighter safety by limiting exposure to harmful contaminants and supporting overall health. Additionally, the station will feature a modern selective alert

system, which ensures that only the sleeping quarters for the dispatched apparatus receive alerts. This targeted notification system contributes to improved sleep hygiene and the long-term well-being of firefighters.

With a focus on sustainability and adaptability, Fire Station 16 is being built to last for 50 years and designed to accommodate future growth. The station will be capable of housing multiple apparatus, ensuring it can meet the evolving needs of the

community and support the potential addition of new emergency response vehicles in the years to come.

As planning and development continue, we remain committed to creating a fire station that enhances public safety, prioritizes firefighter wellness, and serves the community for decades. We look forward to sharing more updates as this important project progresses.

# The Impacts of Peer Support

Our team has made significant strides in expanding and enhancing its Peer Support Program, ensuring that firefighters and staff have access to vital mental health resources and a strong support network. By prioritizing resilience, well-being, and open communication, the program continues to make a lasting impact on our organization's culture.

In the past couple of years, Renton RFA conducted over 100 Kitchen Table Talks among its crews, creating a safe space for discussions on mental health and workplace challenges. Additionally, the Peer Support Team has played a role in an ongoing series of Q & A sessions

titled, "Ask the Chief," led by Fire Chief Steve Heitman, which aim to foster open dialogue and trust. The organization also hosted its first Peer Support Retreat, bringing members together for operational and personal resilience exercises.

Access to mental health resources expanded with the addition of two new therapists and over 26 professional referrals, while station visits by mental health professionals helped build familiarity and trust.

On the innovation front, Renton RFA secured a \$100K grant to develop PeerCommand, a digital platform designed to integrate resilience tools

and resource navigation specifically for public service members.

Through education, training, and peer-led initiatives, Renton RFA continues to break down barriers to mental health support, ensuring that every member has the resources they need to thrive in high-stress situations, because healthy firefighters contribute to healthy communities.
