Levy Lid Lift Discussion

Chief Heitman reported Renton RFA has hired consultants Chris Faucet and Karen Reed for the August 2023 Proposition 1 campaign. The Chief suggested a joint effort with King County Fire District 40, including a mailer to all the citizens in both jurisdictions. Katie Lewis, with Renton RFA, would lead communications, explaining the funding system to citizens. Renton RFA will cover all consultant expenses, there is no cost to Fire District 40, aside from mailers and postage.

 A local resident made a fifty-dollar donation to the fire district. A receipt and thank you note was sent in return.

UNFINISHED BUSINESS

Cell Tower Lease Update

 Board Attorney Quinn reported the fully executed lease was sent to Verizon on January 10, 2023. Verizon must deliver the thirty-thousand dollar signing bonus, five-thousand dollars in attorney fees, and fortythousand dollars for calendar year 2023 rent within 30-days.

<u>District 40 Regular Meeting Options</u>

 Commissioner Ryan reviewed meeting location options she has researched. The Fairwood Golf and Country Club charges for use of their meeting room. The Fairwood Library meeting schedule is too inconsistent and does not offer Wednesday's. She suggested the use of Renton RFA Station 13 or move the aid car out of the Station 17 bay. Commissioner Parsons said he will ask both Renton RFA and Puget Sound Fire if either can accommodate the Fire District 40 hybrid meeting on a regular basis on either the 2nd Wednesday of every month at 6PM or the 2nd Thursday of every month at 6PM.

<u>District Computer Maintenance Discussion</u>

 Commissioner Ryan would like to investigate the cost of Puget Sound Fire or Renton RFA IT maintenance for the district computer. District Secretary Buckley will contact both entities for a quote.

Benefit Charge Petition Notifications

 District Secretary Buckley presented the final mailer sent to district residents notifying them of the benefit charge petition hearing.

Policy Review (Update): 2741 & 2741P Travel/Training Expenses

Commissioner Pratt presented a modified Policy # 2741P Travel/Training Expenses. There was discussion on the rate to be used for mileage and per diem, it was agreed to use the standard GSA rate which changes with inflation/deflation. The annual travel allowance of \$1,500 per year per commissioner may need to be increased due to rising costs in registrations, hotel accommodations, mileage and/or air transportation, and per diem costs. The Policies & Special Projects workgroup will bring a revised policy to the February 22, 2023 board meeting.

FINANCIAL REPORTS:

Commissioner Sartnurak presented the Q4 2022 Financial Activity Report for review.

Commissioner Ryan stated there are residual funds showing in three (3) funds closed by resolution and converted into the Consolidated Reserve Fund; King County states it will be resolved for fiscal year-end 2022 with adjustments made in January 2023.
