# **CALL TO ORDER + MOTION FOR ABSENT COMMISSIONERS:**

Commissioner Nichelson called the regular meeting of King County Fire Protection District #40 to order at 5:00 PM with Commissioners Little, Ryan, and Sartnurak present.

Commissioner Nichelson led the pledge of allegiance.

#### **FIRE BENEFIT CHARGE (FBC HEARING):**

Commissioner Nichelson called the Benefit Charge Petition Review Hearing of King County Fire Protection District #40 to order at 5:06pm (per RCW 52.18.060). Puget Sound RFA Planning Division Chief Larry Rabel presented the 2020 Fire Benefit Charge overview, including year over year comparisons, staff reports, the benefit charge formula and the Board's role in the petition process. A Special Meeting has been scheduled for Thursday, February 27, 2020 at 5pm to review and close the Petition Hearing. The Benefit Charge Petition Review Hearing recessed at 5:28pm.

• WFCA Legislative Report (January 31, 2020)

District Secretary Buckley will be monitoring the status of SB 6216 FMLA Exemption for Fire Commissioners.

This provides fire district and RFA commissioners exemption from payment of family and medical leave program premiums.

Chelan Conference Event (WA State Risk Mgmt Group)

The Board was provided an overview of the event scheduled June 5, 2020 in Chelan, WA.

#### **UNFINISHED BUSINESS:**

Seattle Public Utilities Contract

Seattle Public Utilities made a small amendment to the CPI increase to be assessed within the contract. It was Moved by Commissioner Little to approve the Seattle Public Utilities Contract with the amended changes. Commissioner Sartnurak seconded. Motion approved (4-0).

#### **NEW BUSINESS:**

Station 17 Emergency Sewer Repair

Commissioner Sartnurak reviewed sewer repair at Station 17 after the third clog occurrence. Deputy Chief DeSmith and Facilities Technician Highley determined a blockage of tree roots caused the sewer line to back-up and overflow. Further investigation determined the electrical install of the cell tower on premises broke the access pipe, allowing tree roots to block the sewer line. Commissioner Sartnurak confirms the access pipeline has been replaced and has a life expectancy of 20 years. She recommends the board consider the removal of 2-4 trees on premises to deter new root growth and debris on the Station 17 rooftop.

#### **WORKGROUP REPORTS:**

- <u>Finance</u> (Nichelson + Ryan)
   Former Fire District 40 employee is retiring and reported he was missing service credits. The proper adjustments have been made.
- <u>Communications</u> (Nichelson + Ryan)

A new Fire District 40 newsletter features the newest Fire District 40 Commissioner, Andrew Schneider. The board members will await his approval before sending it to production.

The Fairwood Neighborhood Alliance group met with local Fairwood business owners and local residents Deputy Chief DeSmith, Commissioners Ryan and Sartnurak, and King County Director of Relations Tom Goff. Local businesses are utilizing the new Fairwood Magazine (formerly the Fairwood Flyer) to promote and involve local businesses and residents of Fairwood Crest, West, and Greens.

<u>Facilities & Equipment</u> (Sartnurak + Schneider)

Commissioner Sartnurak reported Facilities Technician Highley contracted a separate roofing company to inspect the condition of the Station 17 roof. The roof is in good shape. It was suggested to apply a commercial roof coat to three separate sections as preventative maintenance; a new coat will be applied in 3-4 years. Blowing away roof debris will help maintain the integrity of the roof.

Commissioners Sartnurak and Schneider attended the Zone 3 meeting regarding fire engine specifications on January 23, 2020. A total of 12 engines are scheduled to be ordered January 2021 zone-wide ideally using identical specifications.

# • Special Projects (Little + Schneider)

Commissioner Little reported she is in contact with WA Corrections Institute for board member shirts, Commissioner Schneider will review the contract and report back.

Revised policies (see minutes of 1/9/2020) will be presented at the next regular meeting.

# • Contract Review & Options (Sartnurak + Little)

After researching possible consultants to help determine the best options for the future of Fire District 40, Commissioner Sartnurak received a proposed scope of work with Emergency Services Consulting International (ESCI). Retired Fire Chiefs Don Bivins, Fire District 40, and Jim Torbin, Northshore Fire will be on the project. ESCI comes highly recommended with decades of consultation experience directly with fire districts. Draft reports containing recommendations scheduled to be available four months from the start of the project. Commissioner Sartnurak recommends ESCI to the Board as the ideal consultant for this project.

It was Moved by Commissioner Little to go into contract with Emergency Services Consulting International. Commissioner Sartnurak seconded. Motion Approved (4-0).

# <u>Renton RFA Liaison</u> (Sartnurak)

Commissioner Sarnurak reported the Renton RFA Board went into Executive Sessions to discuss and approve a letter in response to the letter sent by the Fire District 40 Board of Commissioners regarding Chief Marshall's conduct at the Fire District 40 November 14, 2019 regular meeting.
