#### 2021-2022 Audit Update

Commissioners Ryan advised the board the State Auditors Office will be issuing a Finding to the district due to the interfund transfer process executed in the financial software. While the funds balanced and reconciled to the King County fund balances, the interfund transfers did not eliminate during the fund consolidation process. SAO declined the district's request to reduce the clerical error to a Management Letter despite SAO having made clerical errors in the letter sent to the district indicating incorrect transfer amounts. Jim Torpin drafted a District Response Letter on behalf of the district for review by Board Attorney Quinn. The next step will be the Exit Interview, please let Commissioner Ryan know if you would like to attend.
